AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST AMENDMENT TO  
THE IBI GROUP COMPREHENSIVE OPERATIONAL ANALYSIS OF LOCAL AND  
COMMUTER TRANSIT SERVICE CONTRACT (C-15-213)**


**WHEREAS**, the City of Elk Grove's Transit Division is responsible for acquiring Federal and State funds in order to maintain and improve the City's transit fleet and services; and

**WHEREAS**, the City Council of the City of Elk Grove awarded a contract to IBI Group on June 24, 2015, in an amount not-to-exceed \$112,959 for consulting services to conduct a Comprehensive Operational Analysis (COA) of the City's local and commuter transit services; and

**WHEREAS**, the First Amendment includes an "extension period" through May 31, 2017, increases the not to exceed amount of the contract to \$147,959.00, includes assistance with the implementation of the COA, preparation of a marketing plan, and assistance with a transit equity analysis.

**NOW, THEREFORE BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager, or designee, to execute Amendment #1 to the IBI Group Comprehensive Operational Analysis of Local and Commuter Transit Service Contract.




