**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE BOND ROAD AND BADER ROAD TRAFFIC SIGNAL
INSTALLATION PROJECT (PT0134) AS COMPLETE; AND AUTHORIZING THE CITY
ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on November 18, 2015 the City Council authorized the award of a construction contract to Tim Paxin's Pacific Excavation, Inc. for the Bond Road and Bader Road Traffic Signal Installation Project (Capital Improvement Project ID PT0134) (the "Project"); and

WHEREAS, the Project a rural road traffic signal on wood poles at the intersection of Bond Road and Bader Road; the work included minor improvements to the intersection of Sheldon Road and Grant Line Road, including asphalt paving and curb ramp improvements; and

WHEREAS, Tim Paxin's Pacific Excavation, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Tim Paxin's Pacific Excavation, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Bond Road and Bader Road Traffic Signal Installation Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


