

RESOLUTION NO. 2016-115

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH COMPETITIVE BIDDING AND AUTHORIZING THE CITY
MANAGER TO EXECUTE AN AMENDMENT TO CONTRACT C-09-158 WITH UNION
BANK, FOR A PERIOD OF SIX MONTHS, FOR LOCK BOX SERVICES,
AUTHORIZING AN EXPENDITURE OF \$25,000 [FOR A TOTAL EXPENDITURE OF
FUNDS OVER THE CONTRACT TERM NOT-TO-EXCEED \$447,000]**

WHEREAS, Union Bank currently provides the City's Lock Box Services and has provided high-quality customer service to the City; and

WHEREAS, the current contract terminates June 30, 2016; and


WHEREAS, the City strives to provide the highest quality and most seamless customer service experience to residents while balancing overall costs related to delivering this customer experience; and

WHEREAS, the City is in the process of going out to bid for Lock Box Services; and

WHEREAS, for the reasons presented, it is in the best interest of the City to dispense with the formal competitive bidding procedure pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3) for the services described herein, and to continue its Lock Box Services with Union Bank for a period of six months while the bidding process is completed.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove dispenses with competitive bidding and authorizes the City Manager to execute an amendment to contract C-09-158 with Union Bank, for a period of six months, for Lock Box Services, authorizing an expenditure of \$25,000 [for a total expenditure of funds over the contract term not-to-exceed \$447,000].


