

RESOLUTION NO. 2016-148

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS FOR EMPLOYMENT INVESTIGATION SERVICES WITH ELLIS BUEHLER MAKUS LLP AND BOUTIN JONES, INC., FOR A TERM OF THREE YEARS, IN AN AMOUNT NOT TO EXCEED \$150,000 PER CONTRACT AND A NOT-TO-EXCEED AMOUNT OF \$300,000 COMBINED FOR THE TERM OF THE CONTRACT

WHEREAS, the City Council of the City of Elk Grove recognizes the periodic need to utilize employment investigation services; and

WHEREAS, the City Council is satisfied with the services provided by Boutin Jones, Inc and recognizes Boutin Jones, Inc.'s high level of integrity, efficiency, responsiveness and extensive legal knowledge; and

WHEREAS, the City Council recognizes Ellis Buehler Makus LLP's high quality service in their role assisting in recent employee investigations and the high regard from Ellis Buehler Makus LLP's references indicating their expertise and satisfactory service to a wide range of clients; and

WHEREAS, for the reasons cited, the City Council finds it in the best interest of the City to contract with Boutin Jones, Inc. and Ellis Buehler Makus LLP for employee investigation services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the necessary documents to execute a contract with both Ellis Buehler Makus LLP and Boutin Jones, Inc., for a term of three years, in an amount not to exceed \$150,000 per contract and a not-to-exceed amount of \$300,000 combined for the term of the contract.




