

RESOLUTION NO. 2016-150

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A STREAMBED ALTERATION
AGREEMENT WITH THE CALIFORNIA DEPARTMENT OF FISH AND WILDLIFE
FOR THE ROUTINE MAINTENANCE OF STREAM CHANNELS AND DRAINAGE
FACILITIES IN THE CITY**

WHEREAS, the City of Elk Grove notified the California Department of Fish and Wildlife (DFW) about routine maintenance projects it intends to perform in the stream channels and drainage facilities in the City to maintain the designed capacity of creeks and channels; and

WHEREAS, the DFW determined that a Streambed Alteration Agreement is required pursuant to Fish and Game Code Section 1602 to perform such routine maintenance projects; and

WHEREAS, the DFW has developed a Streambed Alteration Agreement authorizing the City to perform specified routine maintenance projects in the City; and

WHEREAS, an Initial Study was prepared for the project and a Mitigated Negative Declaration (MND) and Mitigation Monitoring and Reporting Program (MMRP) was adopted by City Council on August 12, 2015. No further environmental review is required under State CEQA guidelines Section 15162.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Streambed Alteration Agreement with the Department of Fish and Wildlife for routine maintenance of stream channels and drainage facilities within the City of Elk Grove.


