

RESOLUTION NO. 2016-174

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE-YEAR CONTRACT,
WITH THREE ONE-YEAR EXTENSION OPTIONS, WITH SIERRA DISPLAY
TO PROVIDE GOODS AND SERVICES SUPPORTING THE ECONOMIC
DEVELOPMENT AND MILITARY STREET BANNER PROGRAMS
IN AN AMOUNT NOT-TO-EXCEED \$217,276.02
FOR THE LIFE OF THE CONTRACT**

WHEREAS, the City of Elk Grove utilizes consultants to produce, install, remove, and store street banners displayed in the public right-of-way to promote City events, activities and to bolster civic pride; and

WHEREAS, the City Council has authorized the launch of a new Military Street Banner Program to recognize the estimated 9,000 military veterans residing within the City; and


WHEREAS, the existing contract for street banner goods and services supporting the Economic Development Banner Program will be terminated by December 16, 2016; and

WHEREAS, the City has followed the City's purchasing ordinance requirements by issuing a formal Invitation for Bids to solicit these services and received proposals on July 29, 2016; and

WHEREAS, the proposal submitted by Sierra Display was determined to be the lowest responsive proposal.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a three-year contract, with three one year extension options, with Sierra Display to provide goods and services supporting the Economic Development and Military Street Banner programs in an amount not to exceed \$217,276.02.


