

RESOLUTION NO. 2017-233

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE BRIDGE PREVENTATIVE MAINTENANCE PROJECT (WBR001)
AS COMPLETE; AND AUTHORIZING THE CITY ENGINEER TO PREPARE AND
THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE
SACRAMENTO COUNTY RECORDER**

WHEREAS, on October 12, 2016, the City Council authorized the award of a construction contract to R.A. Nemetz Construction Company, Inc. for the Bridge Preventative Maintenance Project (WBR001); and

WHEREAS, the Project provided preventative maintenance construction for the following four bridges: (1) Bruceville Road (over Laguna Creek): Bridge deck methacrylate treatment, erosion control repair in Laguna Creek; (2) Sheldon Road (over Laguna Creek): Bridge deck methacrylate treatment; (3) Laguna Boulevard (over Union Pacific Railroad): Joint Seal Replacement; (4) Elk Grove Boulevard (over Union Pacific Railroad): Joint seal replacement and concrete slope protection repair; and

WHEREAS, R.A. Nemetz Construction Company, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to R.A. Nemetz Construction Company, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Bridge Preventative Maintenance Project (WBR001) as complete; and

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.




