

RESOLUTION NO. 2018-178

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE COMPETITIVE BIDDING PROCESS PURSUANT TO EGMC 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT NO. 2 TO THE CONTRACT WITH BONG GOO LEE CORPORATION FOR DRY CLEANING SERVICE FOR POLICE UNIFORMS IN THE AMOUNT OF \$20,000 FOR A TOTAL CONTRACT NOT-TO-EXCEED AMOUNT OF \$80,000 THROUGH APRIL 30, 2019

WHEREAS, the Elk Grove Police Department has 145 sworn officer positions which mandate uniform attire; and

WHEREAS, police uniforms require dry cleaning for proper care; and

WHEREAS, staff conducted a competitive bid process to find a dry cleaning service provider that offered the most competitive prices; and

WHEREAS, Moonlight Cleaners offered the most competitive pricing and proven quality service; and

WHEREAS, Bong Goo Lee Corporation purchased Moonlight Cleaners, assuming their rights and obligations for the original contract; and

WHEREAS, Bong Goo Lee Corporation has agreed to continue service to the City at the same pricing and terms found in their agreement;

WHEREAS, for the reasons presented, pursuing a formal competitive bidding process for the dry cleaning services addressed by the proposed amended contract is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution dispensing with competitive bidding process pursuant to EGMC 3.42.188(B)(3) and authorizes the City Manager to execute amendment No. 2 to the contract with Bong Goo Lee Corporation for dry cleaning service for police uniforms in the amount of \$20,000 for a total contract not-to-exceed amount of \$80,000 through April 30, 2019.




