A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE LEFT TURN LANE EXTENSION WESTBOUND LAGUNA
BOULEVARD AT LAGUNA PARK DRIVE (EAST) (WTC012) AND LEFT TURN
POCKET EXTENSION EASTBOUND LAGUNA BOULEVARD AT FRANKLIN
BOULEVARD (WTC013) PROJECTS AS COMPLETE; AUTHORIZING THE CITY
ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER; AND
AUTHORIZING STAFF TO AMEND THE ANNUAL BUDGET AND CAPITAL
IMPROVEMENT PROGRAM BY REDUCING THE REMAINING PROJECT BUDGET
AUTHORITY TO ZERO AND RETURNING ANY REMAINING FUNDS BACK TO
THEIR RESPECTIVE FUND

WHEREAS, on June 13, 2018, the City Council authorized the award of a construction contract to Western Engineering Contractors, Inc. for the Left Turn Lane Extension Westbound Laguna Boulevard at Laguna Park Drive (East) (WTC012) and Left Turn Pocket Extension Eastbound Laguna Boulevard at Franklin Boulevard (WTC013) Projects; and

WHEREAS, the Project provided for construction to increase turning pocket capacity and to keep vehicles from queuing into adjacent through lanes. The project also provided construction for Bike Route signage for cyclists traveling eastbound on Laguna Boulevard as an alternate route around the Franklin Boulevard intersection; and

WHEREAS, Western Engineering Contractors, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Western Engineering Contractors, Inc.; and

WHEREAS, post-construction work is typically completed within one hundred twenty (120) days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid, any remaining project budget authority would be adjusted to zero.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- Accepts the Left Turn Lane Extension Westbound Laguna Boulevard at Laguna Park Drive (East) (WTC012) and Left Turn Pocket Extension Eastbound Laguna Boulevard at Franklin Boulevard (WTC013) Projects as complete;
- Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and

3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by reducing the remaining project budget authority to zero and returning any remaining funds back to their respective fund.
