

**RESOLUTION NO. 2019-020**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST AMENDMENT TO CONTRACT C-16-065 WITH PROFESSIONAL LANDSCAPE SOLUTIONS INC. FOR LANDSCAPING SERVICES OF CITY FACILITIES, EXTENDING THE CONTRACT FOR TWO YEARS AND AUTHORIZING AN EXPENDITURE OF FUNDS NOT-TO-EXCEED \$10,000 [FOR A TOTAL EXPENDITURE OF FUNDS OVER THE TERM OF THE CONTRACT NOT-TO-EXCEED \$165,000]**

**WHEREAS**, landscape maintenance of the City's facilities is necessary in delivering service to the citizens of the City of Elk Grove; and

**WHEREAS**, in February of 2016 the City conducted a formal request for proposals to seek economies of scale and thereby complied with the competitive bid requirements within the City's contracts and purchasing ordinance (Elk Grove Municipal Code Chapter 3.42); and

**WHEREAS**, Professional Landscaping Solutions met all of the criteria in the request for proposal that was determined most advantages to the City and contract C-16-065 was issued; and

**WHEREAS**, Contract C-16-065 allows for amendments, changes, and extensions if those terms are agreeable to both parties. Professional Landscape Solutions Inc. has indicated that they would like to continue providing service to the City under the same pricing, terms and conditions of the existing contract; and

**WHEREAS**, Professional Landscaping Solutions, Inc. has satisfactory provided landscape maintenance to the City.

**NOW, THEREFORE BE IT RESOLVED** that the City Council of the City of Elk Grove authorizes the City Manager to execute the second amendment to contract C-16-065 with Professional Landscape Solutions Inc. of Sacramento for landscape maintenance for City Facilities authorizing an expenditure of funds not-to-exceed \$10,000 [for a total expenditure of funds over the term of the contract not-to-exceed \$165,000] in substantially the form presented with the accompanying staff report and subject o approval by the City Attorney.


