## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN ECONOMIC INCENTIVE AGREEMENT WITH SENSORTRANSPORT, INCORPORATED IN THE AMOUNT OF \$75,000

**WHEREAS**, the Elk Grove City Council has specifically identified startups as a target industry and supporting the launch and growth of startups as a key component of the City's small business support activities; and

**WHEREAS**, the City Council created the Startup Elk Grove Incentive Program to support the launch, growth, and attraction of innovative startup companies that will grow rapidly and become future anchor companies of the Elk Grove economy; and

**WHEREAS**, SensorTransport, Inc. is a high growth potential startup business founded by an Elk Grove resident, and is seeking financing assistance from the Startup Elk Grove Incentive Program to establish corporate headquarters and grow operations within Elk Grove, California; and

**WHEREAS**, pursuant to Section II. SCALEUP of the Program, the City may award incentives to assist high growth potential startup companies located or willing to locate in Elk Grove to defray business costs such as relocation, expansion, operating, product development, equipment, or other legitimate and customary scaling costs.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an Economic Incentive Agreement with SensorTransport, Inc., in substantially the form presented, in the amount of \$75,000.
