

RESOLUTION NO. 2019-167

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH LC
ACTION POLICE SUPPLY, LTD. FOR THE ONE-TIME PURCHASE OF FIREARMS
AND FIREARMS ACCESSORIES FOR THE ELK GROVE POLICE DEPARTMENT IN
AN AMOUNT NOT TO EXCEED \$113,290**

WHEREAS, the Elk Grove Police Department has 150 authorized sworn officer positions requiring firearms to conduct their duties as peace officers; and

WHEREAS, the Elk Grove Police Department is standardizing the types of firearms authorized for use by sworn officers and will now require on-duty officers to carry firearms of the same make, model, and caliber; and

WHEREAS, staff conducted a formal bid process to find a vendor able to provide the firearms and firearms accessories at the best cost and within the timeframe outlined in an Invitation to Bid (ITB); and

WHEREAS, LC Action Police Supply, LTD. offered the most competitive pricing, quality products, and the ability to adhere to the timeframes outlined in the ITB.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an agreement with LC Action Police Supply, LTD., in substantially the form presented, for the one-time purchase of firearms and firearms accessories for the Elk Grove Police Department in an amount not-to-exceed \$113,290.
