

**RESOLUTION NO. 2019-223**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST AMENDMENT TO  
CONTRACT NO. C-16-527 WITH INTERWEST CONSULTING GROUP FOR THE  
DEVELOPMENT SERVICES DEPARTMENT**

**WHEREAS**, on October 12, 2016, the City entered into Contract No. C-16-527 (Contract) with Interwest Consulting Group (Interwest) to provide building permitting and inspection services for the Development Services Department (Department); and

**WHEREAS**, the Contract had a base term of three years (effective December 1, 2016) and included a provision allowing for up to two, one-year extensions, at an amount equal to no more than 42% of all Building Permit and Plan Review revenue received by the City, excluding the portion collected for the Strong Motion Instrumentation Program (SMIP); and

**WHEREAS**, Interwest has adequately performed the required services for the Development Services Department over the base term of the Contract.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the First Amendment to Contract No. C-16-527 with Interwest Consulting Group for the Development Services Department, in substantially the form presented, extending the Contract for an additional one-year term set to expire on November 30, 2020.
