A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ADOPTING A CHARTER FOR COMPASSION FOR THE CITY

- **WHEREAS**, compassion is the act of showing kindness and a willingness to help others and the environment; and
- **WHEREAS**, a plethora of modern research demonstrates the direct community and individual benefits of compassion; and
- **WHEREAS**, a compassionate city dedicates itself to common efforts serving human needs and the natural environment on which everyone ultimately depends; and
- **WHEREAS**, a compassionate city understands that all are connected and affect each other's well-being; and
- **WHEREAS**, a compassionate city looks to expand collaboration and opportunity for all to flourish in health and dignity; and
- WHEREAS, a compassionate city seeks to ensure that all live well: healthy and strong, rich in culture, cultivating relationships to promote the well-being of both individuals and communities; and
- WHEREAS, a compassionate city ensures it is accountable to both current and future generations, meeting the needs and aspirations of present community members while preserving natural resources for those to come; and
- WHEREAS, the City of Elk Grove has a long history of compassion and civic engagement; and
- **WHEREAS**, diversity, inclusiveness, and multiculturalism make the City of Elk Grove a stronger, welcoming, and more vibrant city.
- **NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby adopts this charter for compassion committing to the following principles:
 - 1) Seek for all to thrive through active caring and concern for all people, especially those in need or distress:
 - 2) Expand collaboration and opportunity for all to flourish in health and dignity;
 - Observe how well the community's basic needs are met and work together to find solutions to unmet needs so that all may live up to their potential and flourish;
 - 4) Foster community building with an expanded sense of belonging to and with each other:
 - 5) Encourage education in compassion principles and engagement of young people to build a foundation of sustainability and civic-mindedness;
 - 6) Reach beyond what is comfortable to extend compassion with courage, purpose, and practice;
 - 7) Use a lens of compassion in interactions, decisions, programs and budgets;
 - 8) Focus attention on the well-being of people and the environment; and
 - 9) Care about all people and the world.

AND, BE IT FURTHER RESOLVED that the City Manager is authorized to develop a Compassion Awards Program and guidelines to recognize the City's commitment to creating a compassionate community consistent with the above-described principles.
