**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE LAGUNA CREEK OPEN SPACE PRESERVE TRAIL PROJECT
(WTL022) (FEDERAL PROJECT: ATPL-5479(051)) AS COMPLETE; AND
AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE
THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on June 13, 2018, the City Council authorized the award of a construction contract to Robert A. Bothman Construction, for the Laguna Creek Open Space Preserve Trail Project (WTL022) (Federal Project: ATPL-5479(051)); and

WHEREAS, the Project included approximately one mile of Class I Bikeway (Multi-Use Trail), through an open space preserve, adjacent to Laguna Creek; major improvements included a Class I Bikeway consisting of a 10-foot wide asphalt trail with two-foot decomposed granite shoulders, a 60,000 square foot educational area including eight-foot wide decomposed granite paths and interpretive sign stations, appropriate trail signs, striping, pavement markings, and restoration of native riparian and wetland landscaping; and


WHEREAS, Robert A Bothman Construction has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Robert A. Bothman Construction.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Accepts the Laguna Creek Open Space Preserve Trail Project (WTL022) (Federal Project: ATPL-5479(051)) as complete; and
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.




