

RESOLUTION NO. 2020-145

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DIPSENSING WITH THE COMPETITIVE BIDDING PROCESS PURSUANT TO ELK
GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND AUTHORIZING THE CITY
MANAGER TO EXECUTE AN AGREEMENT WITH THE COUNTY OF SACRAMENTO
FOR SACRAMENTO REGIONAL RADIO COMMUNICATIONS SYSTEM LICENSING**

WHEREAS, the Elk Grove Police Department (EGPD) has been a member of the Sacramento Regional Radio Communications System (SRRCS) since 2006; and

WHEREAS, being a member of SRRCS affords users the benefits of a county-wide radio communications system; and

WHEREAS, SRRCS provides a reliable, efficient radio system and is a trusted regional consortium; and

WHEREAS, interoperability is key to responding to local and regional emergencies; and

WHEREAS, SRRCS provides essential interoperability with agencies throughout the Sacramento region; and

WHEREAS, the current ten-year SRRCS license agreement with the County of Sacramento ends June 30, 2020; and

WHEREAS, pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3), the City Council may dispense with the competitive bidding process when, in the judgment of the City Council, compliance with the procedure is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby finds that, for the reasons presented, a competitive bidding process is not in the best interest of the City and therefore dispenses with the competitive bidding process and authorizes the City Manager to execute an agreement with the County of Sacramento, in substantially the form presented, for Sacramento Regional Radio Communications System licensing.


