

**RESOLUTION NO. 2021-003**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT FOR UP TO FIVE  
YEARS WITH HASA, INC. TO PROVIDE POOL CHEMICALS TO THE ELK GROVE  
AQUATICS CENTER IN AN AMOUNT NOT TO EXCEED \$300,000**

**WHEREAS**, in October 2020, the City issued an invitation to bid (ITB) to seek a company or companies to provide pool chemicals to the Elk Grove Aquatics Center in compliance with the City's contracts and purchasing ordinance (Elk Grove Municipal Code Chapter 3.42); and

**WHEREAS**, the ITB resulted in three proposals being submitted for consideration on October 29, 2020; and

**WHEREAS**, HASA, Inc. met all of the requirements of the ITB and was found to be the lowest responsive and responsible bidder in several chemical categories; and

**WHEREAS**, sufficient funding is identified in the Aquatics Center budget for Fiscal Year 2020-21 for these goods for the remainder of this fiscal year and funding for future years will be programmed in the respective fiscal year's budget.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with HASA, Inc., in substantially the form presented, to provide pool chemicals to the Elk Grove Aquatics Center for a term of up to five years in an amount not to exceed \$300,000.
