

RESOLUTION NO. 2021-290

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH COMPETITIVE BIDDING AND AUTHORIZING THE CITY
MANAGER TO EXECUTE THE FIRST AMENDMENT TO THE CONTRACT WITH L.N.
CURTIS AND SONS MODIFYING THE PRODUCT LIST AND INCREASING
COMPENSATION BY \$25,000 FOR A TOTAL AMOUNT NOT TO EXCEED \$745,000**

WHEREAS, the Elk Grove Police Department has approximately 151 sworn peace officers and 25 non-sworn employees required to wear uniforms to perform their duties in the City of Elk Grove; and

WHEREAS, in 2020, staff publicly announced a Request for Proposals (RFP) seeking suppliers of police uniforms and alterations services that would offer the City of Elk Grove competitive contract pricing; and

WHEREAS, L.N. Curtis and Sons dba Curtis Blue Line offered the most competitive pricing, quality products, and the ability to provide the service as outlined in the RFP, and L.N. Curtis and Sons was awarded a contract with the City; and

WHEREAS, during the term of the contract, the City may need to purchase additional, but similar, items to meet the changing needs of staff and the police department, as well as to adjust to a change of products and inventory offered by L.N. Curtis and Sons; and

WHEREAS, staff identified additional police uniform products needed for the police department and L.N. Curtis and Sons is able to provide the products at competitive pricing;

WHEREAS, for the reasons presented, pursuing a formal bidding process for the purchase of the additional products is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive bidding process pursuant to EGMC 3.42.180(B)(3) and authorizes the City Manager to:


1. Execute the first amendment to the contract with L.N. Curtis and Sons modifying the product list and increasing compensation by \$25,000 for a total amount not to exceed \$745,000; and
2. Execute all future amendments to the agreement concerning extensions of time, increases to individual unit costs as allowed by the contract, and the addition of new products required to meet the needs of the City, provided that such amendments do not result in an increase to the total compensation paid to L.N. Curtis and Sons.
