

RESOLUTION NO. 2022-244

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FOR
CONCENTRATED TRAFFIC ENFORCEMENT STRATEGIES FROM THE
CALIFORNIA OFFICE OF TRAFFIC SAFETY AND AMEND THE POLICE
DEPARTMENT'S BUDGET TO APPROPRIATE GRANT FUNDS UP TO THE
AMOUNT OF \$408,500**

WHEREAS, the California Office of Traffic Safety's mission is to effectively and efficiently administer traffic safety grant funds to reduce traffic deaths, injuries, and economic loss; and

WHEREAS, OTS provides grant funding opportunities to local law enforcement agencies that will support and advance the mission of OTS; and

WHEREAS, the Elk Grove Police Department desires to continue its concentrated traffic enforcement strategies that support OTS and the Department's philosophy of proactive law enforcement; and

WHEREAS, the safety of Elk Grove citizens is the Council's primary concern.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Accept the awarded grant funding up to \$408,500 from the California Office of Traffic Safety to implement concentrated traffic enforcement strategies; and
- 2) Take all action and execute all documents and/or agreements reasonably necessary to receive the grant funding, all subject to approval of any documents and/or agreements as to form by the City Attorney; and
- 3) Amend the Police Department's revenue and expense budget equal to the amount received and expended each fiscal year until the total grant award has been received and expended.
