**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH
GEORGE REED, INC. FOR THE
ASPHALT CONCRETE OVERLAY PROJECT 2004**

WHEREAS, the City of Elk Grove has identified streets within the City requiring asphalt concrete overlay treatment as part of its annual resurfacing program; and

WHEREAS, the City Engineer issued a call for bids on June 16, 2004, and George Reed, Inc. has been determined to be the lowest responsive responsible bidder; and

WHEREAS, project costs will be funded by Gas Tax funds programmed for pavement maintenance.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with George Reed, Inc. for the Asphalt Concrete Overlay Project 2004.


