

RESOLUTION NO. 2015-119

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO CONTRACT C-12-301 WITH INTERSTATE OIL, CO. FOR SUPPLYING BULK AND CARD LOCK FUEL FOR CITY OWNED VEHICLES, EXTENDING THE CONTRACT FOR TWO YEARS AND AUTHORIZING AN ADDITIONAL EXPENDITURE OF FUNDS NOT-TO-EXCEED \$1,230,000 [FOR A TOTAL EXPENDITURE OF FUNDS OVER THE TERM OF THE CONTRACT NOT-TO-EXCEED \$3,210,000]

WHEREAS, the City provides Police Services, Code Enforcement, Facility Services and Integrated Waste Management within the City of Elk Grove requiring the use of unleaded gasoline and diesel fuel for daily operation; and

WHEREAS, in May of 2012 the City announced a request for proposals to provide bulk and card lock fuel services for City owned vehicles; and

WHEREAS, Inter-State Oil, Co. was the lowest responsive and responsible bidder and was awarded contract C-12-301 for supplying the City bulk and card lock fuel services; and


WHEREAS, the contract and award resolution provide that the initial contract was to be for a period of three years, with an option to extend the contract for an additional two years, for a total term not to exceed five years; and

WHEREAS, Inter-State Oil, Co. has satisfactorily provided bulk and card lock fuel for City owned vehicles; and


WHEREAS, funding for this expenditure will be programed in the Fiscal Year 2015-16 and Fiscal Year 2016-17 Fleet Services budgets .

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to execute an amendment to contract C-12-301 with Inter-State Oil, Co. for bulk and card lock fuel for City owned vehicles for an additional two years, and authorizes an additional expenditure of funds not-to-exceed \$1,230,000 [for a total expenditure of funds over the term of the contract not-to-exceed \$3,210,000].




