A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH AMEEX TECHNOLOGIES CORPORATION FOR WEBSITE DEVELOPMENT AND PROFESSIONAL SERVICES AND A SUBSCRIPTION AND SERVICES AGREEMENT WITH ACQUIA FOR WEBSITE HOSTING AND MAINTENANCE, EACH FOR A TERM OF FIVE YEARS WITH THE OPTION FOR THREE ONE-YEAR EXTENSIONS, FOR A TOTAL COMBINED NOT TO EXCEED AMOUNT OF \$719,479 OVER EIGHT YEARS

WHEREAS, the current agreement for website maintenance will expire on July 23, 2022; and

WHEREAS, the City has a need for website maintenance/conversion and professional services in the routine course of business; and

WHEREAS, the City followed its purchasing ordinance requirements by issuing a Request for Proposals to solicit these services; and

WHEREAS, on June 1, 2021, proposals were received from 16 companies; and

WHEREAS, the proposal submitted by Ameex/Acquia was determined to be the most responsive and responsible, demonstrating the competence and professional qualifications necessary for the performance of the required services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a contract with Ameex Technologies Corporation, in substantially the form presented, for website development and related professional services for an initial period of five years with the option to extend the agreement for an additional three one-year terms, for a total contract amount not to exceed \$490,979.00; and
- 2) Authorizes the City Manager to execute a Subscription and Services Agreement with Acquia, in substantially the form presented, for website hosting and maintenance for an initial period of five years with the option to extend the agreement for an additional three one-year terms, for a total contract amount not to exceed \$228,500; and
- Authorizes the City Manager to execute any of the future one-year extensions, provided that the total contract amount does not exceed \$719,479 over the eight-year term.
