## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE SETTING RESIDENTIAL SOLID WASTE SERVICE RATES FOR FISCAL YEAR 2022-23

WHEREAS, pursuant to the Franchise Agreement for Solid Waste Collection Services between the City of Elk Grove (City) and Allied Waste Services of North America, LLC (d.b.a. "Republic Services"), Republic Services is entitled to an annual compensation adjustment to cover inflationary increases in the cost to provide these services; and

WHEREAS, Senate Bill 1383 (SB 1383) sets forth mandates for organics and recycling compliance and requires jurisdictions to adopt municipal ordinances which are designed to progressively achieve California's goal of 75% recycling composting or source reduction of solid waste by 2025; and

WHEREAS, Article XIIID, section 6 of the California Constitution, added by the voters with the passage of Proposition 218 in 1996, contains procedural requirements that must be met whenever a property-related fee is imposed or increased; and

WHEREAS, the City Council of the City of Elk Grove has an obligation to notify all affected property owners and ratepayers of an increase in the rates owed to Republic Services; and

**WHEREAS**, during the first week of April 2022, staff prepared and mailed a notice to all solid waste service customers and all residential property owners notifying them of the proposed rate increase and the public hearing to be held on June 8, 2022; and

WHEREAS, in order for a majority protest to exist, protests equal to 50% of the notices sent out would have to be received.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby finds that no majority protest has been received for the proposed rate increase and sets the Solid Waste Service Rates for FY 2022-23 as shown in the attached Exhibit A incorporated herein by reference, with an effective date of July 1, 2022.
