**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CREDIT REIMBURSEMENT
AGREEMENT WITH REYNEN & BARDIS CONSTRUCTION, LLC FOR PRIVATELY
CONSTRUCTED PUBLIC FACILITIES INCLUDED IN THE ELK GROVE SOUTH
EAST POLICY AREA AND LAGUNA RIDGE SPECIFIC PLAN PHASE 3 DRAINAGE
IMPACT FEE PROGRAM AND CONSTRUCTED FOR THE BENEFIT OF THE TELOS
GREENS PROJECT**

WHEREAS, Elk Grove Municipal Code Section 16.95 provides for reimbursement to developers for the private construction of any facilities designated in the Southeast Policy Area and Laguna Ridge Phase 3 Drainage Impact Fee Program subject to entering into a reimbursement agreement with the City of Elk Grove; and

WHEREAS, Reynen & Bardis, LLC is constructing improvements to the Laguna Ridge Phase 3 Basin which are identified in the Southeast Policy Area and Laguna Ridge Phase 3 Drainage Impact Fee Program as eligible for reimbursement in the form of fee credits.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Reimbursement Agreement with Reynen & Bardis Construction, LLC, in substantially the form presented, for reimbursement by way of credits against future fees from the Elk Grove Southeast Policy Area and Laguna Ridge Phase 3 Drainage Impact Fee Program, with a maximum reimbursement of \$93,307.45.
