

**RESOLUTION NO. 2022-305**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES  
PURSUANT TO ELK GROVE MUNICIPAL CODE CHAPTER 3.42.140(B)(3) AND  
AUTHORIZING THE CITY MANAGER TO EXECUTE THE NINTH AMENDMENT TO  
CONTRACT C-08-242 WITH CORDICO PSYCHOLOGICAL CORPORATION FOR  
SPECIALIZED LAW ENFORCEMENT PSYCHOLOGICAL AND WELLNESS  
SERVICES FOR \$135,000 FOR A TOTAL NOT-TO-EXCEED AMOUNT OF \$391,000  
THROUGH DECEMBER 31, 2025**

**WHEREAS**, law enforcement is a high-stress, often dangerous job that requires persons with mental and emotional stability to successfully perform under such conditions; and

**WHEREAS**, psychological evaluations are a critical component in the decision-making process when hiring police officers; and

**WHEREAS**, wellness resources and services are an important component in ensuring mental wellness of Department employees; and

**WHEREAS**, since 2006, the Elk Grove Police Department has contracted and maintained a long-standing, positive relationship with Cordico Psychological Corporation to perform psychological evaluations and provide wellness resources to Department employees; and

**WHEREAS**, staff conducted a search and found that Cordico Psychological Corporation is the only local provider with the requisite experience in specialized law enforcement psychological screenings and wellness services in the Sacramento area able to meet the needs of the Department; and

**WHEREAS**, pursuant to Elk Grove Municipal Code Sections 3.42.140(B)(3), the City Council may dispense with the formal request for proposals procedure when, in the judgment of the City Council, compliance with the procedure is not in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove finds that a formal request for proposals process is not in the best interest of the City, hereby dispenses with the formal request for proposals procedure, and authorizes the City Manager to execute the Ninth Amendment to Contract C-08-242 with Cordico Psychological Corporation for specialized law enforcement psychological and wellness services increasing the total contract not-to-exceed amount to \$391,000 through December 31, 2025.
