

RESOLUTION NO. 2023-020

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS FOR ON-CALL
TRANSPORTATION PLANNING, DESIGN, AND PROGRAMMATIC SERVICES WITH
SIX FIRMS WITH EACH CONTRACT HAVING A THREE-YEAR TERM AND AN
OPTIONAL TWO-YEAR EXTENSION NOT TO EXCEED BUDGETED AMOUNTS**

WHEREAS, the City of Elk Grove (City) released a Request for Proposals (RFP) in November 2022 soliciting consultants to perform on-call transportation planning, design, and programmatic services; and

WHEREAS, the six proposals received by the City were reviewed and evaluated by a three-person panel comprised of representatives from the City Manager's Office and Department of Public Works (Panel); and

WHEREAS, based on qualifications and experience of the project team, firm experience, project approach and understanding the required scope of work, and supportive information, the Panel determined that all six firms were well qualified to perform these duties; and

WHEREAS, work under the proposed on-call contracts will be authorized through Task Orders, approved by the City Manager or designee; task orders will include the scope of work, not-to-exceed cost for services, and a schedule for completion of the specified work.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute master services contracts with the following six firms, in substantially the forms presented, for On-call Transportation Planning, Design, and Programmatic Services, with each contract having a three-year term and an optional two-year extension not to exceed budgeted authority:


