**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH  
CYBER PROUD, INC. TO PROVIDE WORKFORCE DEVELOPMENT TRAINING  
SERVICES TO ELK GROVE RESIDENTS IN THE FIELDS OF INFORMATION  
TECHNOLOGY AND CYBER SECURITY FOR A TOTAL NOT-TO-EXCEED AMOUNT  
OF \$353,158**

**WHEREAS**, workforce development efforts are critical for the City of Elk Grove (City) to ensure a vibrant, healthy, and diverse local economy; and

**WHEREAS**, the City received American Rescue Plan Act funding to address the impacts of the coronavirus (COVID-19) pandemic; and

**WHEREAS**, the City allocated American Rescue Plan Act funding for economic development initiatives including workforce development training programs intended to upskill and re-employ Elk Grove residents unemployed or underemployed as a result of the pandemic; and

**WHEREAS**, City staff has conducted a formal solicitation of proposals for workforce development service providers in the information technology industry; and

**WHEREAS**, Cyber Proud, Inc. is a qualified non-profit organization that provides the desired training services in the fields of information technology and cyber security.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with Cyber Proud, Inc., in substantially the form presented, for a term of 24 months and a total contract amount not-to-exceed \$353,158.
