

**RESOLUTION NO. 2023-096**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE  
PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR  
SERVICES FOR INDEPENDENT CONTRACTOR WITH CIVICWELL (FORMERLY  
THE LOCAL GOVERNMENT COMMISSION) FOR THE PROVISION OF SERVICES  
THROUGH THE CIVICSPARK PROGRAM, IN AN AMOUNT NOT TO EXCEED  
\$93,000**

**WHEREAS**, the City of Elk Grove (City) is committed to supporting resilience, addressing climate change, creating environmental sustainability, strengthening active transportation options, and decreasing homelessness and increasing affordable housing options for Elk Grove residents; and

**WHEREAS**, the CivicSpark program provides dedicated capacity-building support for local public agencies to address community resilience issues including climate change, housing, and mobility; and

**WHEREAS**, the City desires to have three CivicSpark Fellows to support efforts around climate change, active transportation, organic waste, and housing; and

**WHEREAS**, for the reasons presented, pursuit of a formal competitive proposal process is not in the best interest of the City for the proposed services.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3) and authorizes the City Manager to execute an Agreement for Services for Independent Contractor with CivicWell (formerly the Local Government Commission), in substantially the form presented, for the provision of services through the CivicSpark Program, in an amount not-to-exceed \$93,000.
