

RESOLUTION NO. 2023-208

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR WITH CIVICWELL (C-23-260) FOR THE PROVISION OF SERVICES THROUGH THE CIVICSPARK PROGRAM, ADJUSTING THE SCOPE OF WORK, REDUCING THE TOTAL SERVICE AGREEMENT AMOUNT TO \$58,900, AND AUTHORIZING THE CITY MANAGER TO APPROVE FUTURE SCOPE OF WORK AND BUDGET REVISIONS PROVIDED THEY DO NOT RESULT IN AN INCREASE IN THE NOT-TO-EXCEED AMOUNT OF THE CONTRACT

WHEREAS, the City of Elk Grove (City) is committed to supporting resilience, addressing climate change, creating environmental sustainability, and increasing affordable housing options for Elk Grove residents; and

WHEREAS, the CivicSpark program provides dedicated capacity building support for local public agencies to address community resilience issues including climate change, water resources management, housing and mobility; and

WHEREAS, the City executed a service agreement with CivicWell for three CivicSpark Fellows on May 10, 2023, to support initiatives of the Strategic Planning and Innovation, Recycling and Waste, and Housing divisions; and

WHEREAS, adjusting the scope of work to reduce support for the Recycling and Waste division will best utilize the capacity of the Recycling and Waste team; and

WHEREAS, adjusting the total service agreement amount to \$58,900 reduces the cost for the Fellows, saving the City money; and

WHEREAS, CivicWell provides a discount for agencies that provide a lump sum payment for the CivicSpark program;


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an amendment to the Agreement for Services of Independent Contractor with CivicWell (C-23-260), in substantially the form presented, adjusting the scope of work to remove Recycling and Waste support, reduce the total service agreement amount to \$58,900, and further authorizing the City Manager to approve future scope of work and budget revisions and/or contract amendments provided that such revisions or amendments do not result in an increase in the not-to-exceed amount of the contract.
