

RESOLUTION NO. 2023-210

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE
PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND
AUTHORIZING THE CITY MANAGER TO EXECUTE A MASTER SERVICES
CONTRACT WITH HUNTING ENVIRONMENTAL, LLC FOR ON-CALL
ENVIRONMENTAL SERVICES**

WHEREAS, staff has identified the need to have additional resources available to assist in the support of processing long-range strategic projects and private development projects, including environmental review; and

WHEREAS, Section 3.42.140(B)(3) of the Elk Grove Municipal Code (EGMC) allows the City Council to dispense with the formal request for proposal procedure when it determines that this procedure is not in the best interest of the City; and

WHEREAS, Hunting Environmental, LLC (Hunting) has previously qualified for and was awarded a contract through the City's formal proposal procedure based on their expertise; and

WHEREAS, Hunting has satisfactorily completed tasks for environmental work for the City and in doing so has become familiar with the City's General Plan, Zoning Code and other land use regulation documents, and environmental review processes, which will allow them to perform future tasks more efficiently; and

WHEREAS, for the reasons presented, staff recommends dispensing with the formal request for proposal process for the proposed contract with Hunting.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3) and authorizes the City Manager to execute a Master Services Contract with Hunting Environmental, LLC, in substantially the form presented, for on-call environmental services.
