

RESOLUTION NO. 2023-216

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL BIDDING PROCEDURE PURSUANT TO ELK
GROVE MUNICIPAL CODE SECTION 3.42.180(B)(4) AND AUTHORIZING THE CITY
MANAGER TO EXECUTE A CONTRACT WITH DOWNTOWN FORD SACRAMENTO,
A CALIFORNIA CORPORATION DBA DOWNTOWN FORD SALES FOR THE
PURCHASE OF THREE ADDITIONAL AND TWO REPLACEMENT FORD F-150
PICKUPS AND TWO ADDITIONAL AND ONE REPLACEMENT FORD MAVERICK
PICKUPS IN AN AMOUNT NOT-TO-EXCEED \$300,000**

WHEREAS, the City of Elk Grove's Fleet division maintains all City vehicles and procures replacements and additional when necessary; and

WHEREAS, the City's Fleet division has identified three pickups that have reached the end of their useful life of City service and are required to purchase an additional five pickups; and

WHEREAS, the State of California opened a competitive bidding process for the purchase of Ford F-150 and Maverick pickups; and


WHEREAS, Downtown Ford Sacramento, a California corporation, dba Downtwon Ford Sales (Downtown Ford) was awarded the State of California's large quantity contract for Ford F-150 and Maverick pickups, which was competitively bid; thus, the City is receiving a competitive price and the expenditures of staff time and money to compile the necessary bid documents a second time for a small number of vehicles will not likely result in a better price or an outcome more advantageous to the City; and

WHEREAS, for the reasons presented, it is not in the best of interest of the City to conduct formal bidding for the purchase of the subject vehicles.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby determines that formal competitive bidding is not in the best interest of the City for the subject vehicles and hereby dispenses with the formal bidding requirements pursuant to the Elk Grove Municipal Code Section 3.42.180(B)(4) for a contract for the purchase of the subject vehicles; and


BE IT FURTHER RESOLVED that the City Manager is hereby authorized to execute a contract with Downtown Ford, in substantially the form presented, and funded as referenced in Table 1 of the staff report, for the purchase of five Ford F-150 pickups and three Ford Maverick pickups in an amount not-to-exceed \$300,000.


