**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AMENDMENT  
WITH CYBER PROUD, INC. TO PROVIDE WORKFORCE DEVELOPMENT  
TRAINING SERVICES TO ELK GROVE RESIDENTS IN THE FIELD OF  
INFORMATION TECHNOLOGY FOR A TOTAL NOT-TO-EXCEED AMOUNT OF  
\$1,110,508**

**WHEREAS**, workforce development efforts are critical for the City of Elk Grove (City) to ensure a vibrant, healthy, and diverse local economy; and

**WHEREAS**, the City allocated American Rescue Plan Act of 2021 (ARPA) funding for economic development initiatives including workforce development training programs intended to upskill and employ Elk Grove residents unemployed or underemployed because of the COVID-19 pandemic; and

**WHEREAS**, following a Request for Proposal (RFP) process, Cyber Proud, Inc. was awarded a contract to provide workforce development training programs and services in the field of information technology for up to 40 Elk Grove residents; and

**WHEREAS**, Cyber Proud, Inc. has received significant interest from Elk Grove residents for the training programs and services beyond the available number of program openings; and

**WHEREAS**, increasing the number of available training openings is consistent with the goals of the City's Workforce Development Program, ARPA funds are available for this purpose, and increased openings will result in more residents being employment ready.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the contract amendment with Cyber Proud, Inc., in substantially the form presented, for an extended term through December 31, 2025, and a total contract amount not-to-exceed \$1,110,508.
