A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE CONTRACT WITH CIVICPLUS, LLC, FOR THE LICENSING AND MAINTENANCE OF THE SEECLICKFIX DATA APPLICATION FOR A SEVEN YEAR TERM AND A TOTAL NOT-TO-EXCEED AMOUNT OF \$207,958.67

WHEREAS, staff previously searched for an application that could integrate with both the City's work management system and Public Works' computerized maintenance management system software, and found SeeClickFix was an industry leader in citizen request management solutions and the only application that integrated with both systems; and

WHEREAS, the City entered into a Consulting Services Agreement with CivicPlus for the implementation and maintenance of SeeClickFix, and went live with the app on February 14, 2022; and

WHEREAS, SeeClickFix has been in use since February 14, 2022, has positively affected internal operations, and has met current expectations and continues to improve functions; and

WHEREAS, sufficient funding is identified in the Fiscal Year 2023-24 Budget for the first additional year of licensing for the SeeClickFix software and costs for future years will be included in the respective fiscal year budgets for the term of the contract; and

WHEREAS, conducting a formal request for proposal procedure for the proposed software licensing and maintenance is not in the best interest of the City as this would cause an interruption in service and may result in increased costs and SeeClickFix was previously selected as the best overall value for the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3); and authorizes the City Manager to execute an amendment to the contract with CivicPlus, LLC, in substantially the form presented, for the licensing and maintenance of the SeeClickFix software for a seven-year period, for a total not-to-exceed amount of \$207,958.67.
