

RESOLUTION NO. 2023-263

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES
PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND
AUTHORIZING THE CITY MANAGER TO EXECUTE THE THIRD AMENDMENT
TO THE AGREEMENT WITH SUTTER MEDICAL FOUNDATION FOR POLICE
MEDICAL EVIDENTIARY EXAMINATION SERVICES MODIFYING PRICING AND
INCREASING COMPENSATION BY \$300,000 FOR A TOTAL CONTRACT
AMOUNT NOT TO EXCEED \$600,000**

WHEREAS, police medical evidentiary examinations are critical to the investigation and prosecution of sex assault crimes; and

WHEREAS, reliable medical professionals with requisite experience are required to perform the evidentiary examinations; and

WHEREAS, Sutter Valley Medical Foundation dba Sutter Medical Foundation (Sutter) has provided the Elk Grove Police Department with police medical evidentiary examinations for over ten years; and

WHEREAS, Sutter is the sole provider in Sacramento County of evidentiary examinations for law enforcement and possesses the certification necessary for the examinations to be used in the court of law; and

WHEREAS, pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3), the City Council may dispense with the formal request for proposals procedure when, in the judgment of the City Council, compliance with the procedure is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove finds that a formal request for proposals process is not in the best interest of the City and hereby dispenses with the formal request for proposals procedure pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3), and authorizes the City Manager to execute Amendment Three to the agreement with Sutter Valley Medical Foundation dba Sutter Medical Foundation for police medical evidentiary examinations, modifying pricing and increasing compensation by \$300,000 for a total contract amount not to exceed \$600,000.
