

**ORDINANCE NO. 32-2006**

**AN ORDINANCE OF THE CITY COUNCIL  
OF THE CITY OF ELK GROVE REPEALING CERTAIN CHAPTERS OF THE ELK  
GROVE MUNICIPAL CODE RELATING TO PERSONNEL AND MODIFYING ELK  
GROVE MUNICIPAL CODE SECTION 2.09**

**WHEREAS**, the City adopted the County's Code upon incorporation, and

**WHEREAS**, some of the provisions of those adopted County Codes relating to personnel are no longer useful,

**NOW THEREFORE**, the City Council of the City of Elk Grove does hereby ordain:

**SECTION 1:** The following specified chapters of the Elk Grove Municipal Code are hereby repealed:

Chapters 2.08, 2.10, 2.11, 2.12, 2.14, 2.15, 2.17, 2.19, 2.20, 2.21, 2.22, 2.23, 2.26, 2.28, 2.29, 2.33, 2.35, 2.36, 2.38, 2.39, 2.44, 2.45, 2.46, 2.47, 2.52, 2.58, 2.75, 2.94, 2.96, 2.97, 2.98, 2.99, 2.110, 2.135, 2.145, and 2.150.

**SECTION 2:** Amend Chapter of the Municipal Code:

The City Council hereby amends Chapter 2.09 in its entirety to read as follows:


"2.09.010 Personnel Policies and Procedures.

The City Manager has the responsibility and authority to ensure that proper Personnel Policies and Procedures are in place for the efficient and effective running of the City and can modify or amend said policies as he/she deems necessary. For purposes of this section Policies and Procedures includes defining and implementing premium pay practices, but does not include salary range setting which is subject to approval of the City Council."

**SECTION 3.** Codification:


The City Clerk is directed to renumber this ordinance and its various sections, as necessary, as a part of the Clerk's re-codification project.


