Overall Progress Narrative:

After working through the final touches, the City fully implemented the Downpayment Assistance Program this quarter and began to make loans to first-time homebuyers. After months of working with local realtors, lenders, and prospective homebuyers, the City has offered assistance to two low-income households in the form of a downpayment toward the purchase of their first home; and several more applications are pending for approval. The lack of supply of foreclosed homes is often cited as the main obstacle in taking advantage of the program. The program is on track to fully expend the funds allocated by September 2010. We anticipate another 8-10 downpayment loans being made.

The City also received two responses to the RFP for the City&rsquos NSP Very Low-Income Housing Acquisition and Rehabilitation Program. The program aims to acquire and lease six affordable housing units for very low-income households. The City met in November to discuss the two proposals, and selected a non-profit which, among other qualifying criteria, demonstrated a strong ability to: (1) acquire and finance foreclosed and/or abandoned properties; (2) rehabilitate the properties in a quick and cost-effective manner; (3) market, solicit, and select eligible tenants; and (4) adequately manage the properties and tenants during the duration of property ownership. The City began to draft the contract between the City and the non-profit, and hopes to move forward in the next quarter.

Finally, the City began to draft the RFP for the Affordable Housing Acquisition, Rehabilitation and Resale Program, which provides up to \$1,000,000 for the acquisition, rehabilitation, and resale of affordable housing units deed restricted for 55 years. The City will release the RFP next quarter and evaluate the responses at that time.

The City looks forward to continuing to offer the Downpayment Assistance Program to first-time homebuyers in the next quarter, as well as initiate both affordable housing rehabilitation projects before the quarter&rsquos end.
