**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING A PUBLIC CONVENIENCE AND NECESSITY LETTER
TARON SHELL, PROJECT NO. EG-04-750**

WHEREAS, Tooley Oil Company (hereinafter referred to as Applicant) filed an application with the City of Elk Grove (hereinafter referred to as City) for a Public Convenience and Necessity Letter to obtain a Type 20 Off-sale (beer and wine) alcohol license (Assessor's Parcel Numbers 132-0460-082); and

WHEREAS, Title 4, Chapter 4.60, of the City of Elk Grove Municipal Code establishes the City Council as the appropriate authority to hear and decide all Public Convenience and Necessity Letters; and

WHEREAS, the project is exempt under the California Environmental Quality Act (CEQA) Section 15061 (3); and

WHEREAS, a duly advertised public hearing notice; in accordance with Government Code Section 65090 et. al. and a public hearing was conducted by the City Council on February 2, 2005; and

WHEREAS, after careful consideration of all the written materials and testimony received, the City Council approved the project.

NOW, THEREFORE, BE IT RESOLVED, THE CITY COUNCIL OF THE CITY OF ELK GROVE HEREBY RESOLVES AS FOLLOWS:

1. Approve the request by Taron Shell (EG-04-750) for a Type 20 Off-sale (beer and wine) alcohol license.


