**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO EXECUTE A
CONTRACT WITH MARTIN GENERAL ENGINEERING, INC. FOR CONSTRUCTION
OF THE LAGUNA BOULEVARD REHABILITATION PROJECT**

WHEREAS, the pavement along Laguna Boulevard from Dwight Road/Babson Road to Bruceville Road has been identified to receive an asphalt overlay to improve ride quality and extend pavement life; and

WHEREAS, in conjunction with the asphalt overlay, curb ramp improvements within the overlay limits will be constructed to provide for handicap accessibility and enhance pedestrian safety and will meet the requirements of the Americans with Disabilities Act and California Code of Regulations Title 24; and

WHEREAS, improvement design and construction bid documents are coordinated with and approved by the State Department of Transportation for Federal funding; and

WHEREAS, staff determined that Martin General Engineering, Inc. was the lowest responsive, responsible bidder; and

WHEREAS, project costs will be funded through Federal Surface Transportation Funds, Measure A Construction funds and Laguna West CFD funds.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager, or his designee, to execute a contract with Martin General Engineering, Inc. for construction of the Laguna Boulevard Rehabilitation Project. The contract shall be executed based on the base bid plus Alternative B in the amount of \$2,010,438.45.


