**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO EXECUTE A  
CONTRACT FOR PROFESSIONAL APPRAISAL AND RIGHT-OF-WAY  
ACQUISITION SERVICES WITH BENDER ROSENTHAL INC. FOR THE SHELDON  
ROAD/STATE ROUTE 99 INTERCHANGE PROJECT**

**WHEREAS**, the Sheldon Road/State Route 99 Interchange Project holds a high priority in the City of Elk Grove Transportation Capital Improvement Program; and

**WHEREAS**, the City requires right-of-way acquisition and appraisal services to be provided involving 46 properties in conjunction with the Sheldon Road/State Route 99 Interchange Project; and

**WHEREAS**, staff has determined that Bender Rosenthal Inc. is best qualified to provide the right-of-way acquisition and appraisal services required for this project.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager, or his designee, to execute a contract with Bender Rosenthal Inc. for right-of-way acquisition and appraisal services for the Sheldon Road/State Route 99 Interchange Project in an amount not to exceed \$608,245.


