

RESOLUTION NO. 2006-6

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE GRANT LINE ROAD/BOND ROAD TRAFFIC INTERSECTION
IMPROVEMENT PROJECT AS COMPLETE, AUTHORIZING THE CITY ENGINEER TO
FILE A NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY
RECORDER, AND AUTHORIZING AN ADDITIONAL APPROPRIATION FOR THE
PROJECT**

WHEREAS, on May 25, 2005, the City Council authorized the award of a contract to Martin General Engineering, Inc. for the construction of the Grant Line Road/Bond Road Intersection Improvement Project; and

WHEREAS, the contract called for installation of a traffic signal system, realignment of Bond Road, and associated roadway striping at the intersection of Grant Line Road and Bond Road; and

WHEREAS, Martin General Engineering, Inc. has completed the work for the Grant Line Road/Bond Road Intersection Improvement Project in accordance with the contract documents; and


WHEREAS, if no liens or claims have been filed within 35 days from the filing of the Notice of Completion, retention for the project will be released to Martin General Engineering, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Grant Line Road/Bond Road Intersection Improvement Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to file a Notice of Completion for the Grant Line Road/Bond Road Intersection Improvement Project with the Sacramento County Recorder.

BE IT FURTHER RESOLVED that the authorized appropriation for the subject project is hereby increased by \$25,000 from \$1,700,000 to \$1,725,000, with the additional funding to come from the Elk Grove Roadway Fee Program contingency account.


