

RESOLUTION NO. 2006-113

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE LAGUNA GATEWAY LANDSCAPING PROJECT AT STATE
ROUTE 99 AND LAGUNA/BOND ROAD INTERCHANGE AS COMPLETE AND
AUTHORIZING THE CITY ENGINEER TO FILE A NOTICE OF COMPLETION WITH
THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on July 21, 2004, the City Council authorized the award of a contract to Watkin & Bortolussi, Inc. to perform the Laguna Gateway Landscaping Project on the State Route 99 and Laguna/Bond interchange; and

WHEREAS, the contract called for clearing of weeds and dead plants, installation of trees, shrubs and groundcover, maintaining existing plants, installation of cobble rocks, upgrading the existing irrigation system and improvements to traffic safety and maintenance amenities; and

WHEREAS, Watkin & Bortolussi, Inc. has completed the work in accordance with the contract for the Laguna Gateway Landscaping Project; and


WHEREAS, the City will continue the maintenance of the landscape areas as provided for under the Landscape Maintenance Agreement executed with the State Department of Transportation and approved by resolution by Council on October 13, 2003; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, retention and any remaining amount due will be released to Watkin & Bortolussi, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Laguna Gateway Landscaping Project as complete.






