

RESOLUTION NO. 2006-124

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
FOR PAYING AND REPORTING THE VALUE OF
EMPLOYER-PAID CONTRIBUTIONS**

WHEREAS, the governing body of the City of Elk Grove has the authority to implement Government Code Section 20636(c) (4) pursuant to Section 20691; and

WHEREAS, the governing body of the City of Elk Grove has a written labor policy or agreement which specifically provides for the normal member contributions to be paid by the employer, and reported as additional compensation; and


WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the governing body of the City of Elk Grove of a resolution to commence paying and reporting the value of said Employer Paid Member Contributions (EPMC); and

WHEREAS, the governing body of the City of Elk Grove has identified the following conditions for the purpose of its election to pay EPMC:

- This benefit shall apply to all employees of miscellaneous class.
- This benefit shall consist of reporting 8% of the EPMC as compensation earnable (excluding Government Code section 20636(c) (4)) as additional compensation.
- The effective date of this resolution shall be May 24, 2006.





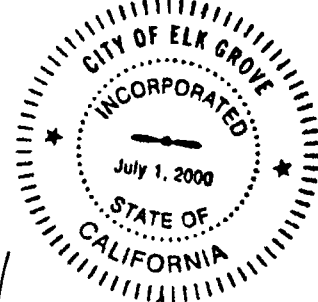
