**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO APPROVE A  
PURCHASE ORDER WITH RAYMER INFORMATION TECHNOLOGY  
AND AMEND THE 2006-07 POLICE DEPARTMENT BUDGET**


**WHEREAS**, a vehicle based computer system is a critical component of the City's Police Department; and

**WHEREAS**, the Panasonic Toughbook laptop computers will include Global Positioning System (GPS) and built in wireless technology. Computer Aided Dispatch (CAD), Record Management System (RMS) software will be installed on the Panasonic Toughbooks to successfully operate the system; and

**WHEREAS**, a RFQ was issued and a selection process was completed that determined Raymar Information Technology was the best supplier to meet the City's needs for Panasonic Toughbooks for the Elk Grove Police Department; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager, or his designee, to approve a purchase order in the amount of \$113,714 for 20 Panasonic Toughbooks (laptop computers) from Raymar Information Technology and to transfer \$57,000 from the General Fund Police Reserve, and \$56,000 from the Police Capital Facilities Fee Fund to the 2006-07 Police Department Budget.


