
**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY ENGINEER TO SUBMIT AN EXPENDITURE PLAN
REQUEST TO THE SACRAMENTO TRANSPORTATION AUTHORITY FOR THE
CITY OF ELK GROVE FISCAL YEAR 2004-05 AND 2005-06 MEASURE A
INTEREST AND SUPPLEMENTAL ALLOCATIONS AND AMEND THE FISCAL YEAR
2006-07 BUDGET**

WHEREAS, the Sacramento Transportation Authority has calculated and approved the Fiscal Year (FY) 2004-05 and 2005-06 Measure A interest and supplemental allocations available to eligible agencies within Sacramento County; and

WHEREAS, in order to be eligible for the supplemental allocations, totaling \$789,301, the City of Elk Grove must submit an expenditure plan request to the Sacramento Transportation Authority.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to submit an expenditure plan request for the City of Elk Grove FY 2004-05 and 2005-06 Measure A Interest and Supplemental Allocations of \$789,301, which is to be applied as \$368,168 to the Pavement Maintenance component, \$335,000 to the Project Study Report/Advanced Planning component, and \$86,133 to the Bicycle and Pedestrian Component of the City of Elk Grove Measure A expenditure plan; and amend the Fiscal Year 2006-07 budget by adding \$789,301 in Measure A revenues and expenditures.




