

RESOLUTION NO. 2007-1

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO PURCHASE
UNLEADED GASOLINE DELIVERED IN BULK FROM HUNT & SONS, INC AND
UNLEADED GASOLINE AND DIESEL FUEL THROUGH THE USE OF CARD LOCK
FUELING FACILITIES FROM FERRELLGAS TO FUEL THE CITY'S VEHICLE FLEET**

WHEREAS, the City provides police services, transit services and community enhancement within the City of Elk Grove requiring the use of unleaded gasoline and diesel fuel for daily operation; and


WHEREAS, the City has conducted a joint procurement for fuel with the Elk Grove Unified School District to seek economies of scale; and

WHEREAS, the City has determined to have fuel delivered in bulk to the Police Fleet Facility and to use card lock fueling facilities for Transit Services and to a lesser extent the Police Department and Community Enhancement.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove does authorize the City Manager or his designee:


- 1) to issue a purchase order with Hunt & Sons, Inc. to have unleaded gasoline delivered in bulk for the current fiscal year 06/07 year with an option of two (2) one (1) year extensions, and;
- 2) to issue a purchase order with Ferrellgas to purchase unleaded gasoline and diesel fuel from card lock facilities for the current fiscal year 06/07 year with an option of two (2) one (1) year extensions.




