

RESOLUTION NO. 2007-210

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE PURCHASING OFFICER TO EXERCISE THE SALE AND
DISPOSAL OF SURPLUS CITY PROPERTY IN THE FORM OF POLICE AND
TRANSIT VEHICLES, AND ASSOCIATED EQUIPMENT**

WHEREAS, in September 2005, the City Council approved the purchase of the police fleet from the Sacramento County Sherriff's Department; and

WHEREAS, the City Council authorized the purchase of new patrol vehicles to replace aging vehicles that were part of the fleet purchased from the County; and

WHEREAS, in February 2007, the City Council approved the transfer of Compressed Natural Gas (CNG) buses from South Coast Area Transit and METRO Regional Transit Authority to replace Diesel buses in the City Transit Fleet and;


WHEREAS, police vehicles are equipped with emergency response and transport equipment that must be removed prior to public sale, and;

WHEREAS, City Ordinance 6-2007 specifies the terms and conditions for the disposition of surplus City property, and;


WHEREAS, the City of Elk Grove desires to surplus seventeen (17) vehicles and their emergency response and transport equipment, one (1) trailer and axle assembly, and sixteen (16) transit buses, and sell or dispose of the assets at fair market value.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the Purchasing Officer, to exercise the sale or disposal of surplus property in the form of seventeen (17) vehicles, one (1) trailer, and sixteen (16) transit buses. This includes the disposal of their associated emergency response and transport equipment through sale to other law enforcement agencies, reuse by the City, or designate as unsalvageable, based on the needs of the City. Monies from the sale or disposal of surplus police vehicles and equipment will be deposited into the City General Fund. Monies from the sale and disposal of transit vehicles will be deposited into the Transit Fund.


