WHEREAS, the City is currently using County of Sacramento Improvement Standards, Standard Construction Specifications and Standard Drawings;


WHEREAS, the City has conducted a thorough collaborative process to solicit input and comments from stakeholders;

WHEREAS, the City has completed City Improvement Standards, Construction Specifications and Standard Drawings that benefit the City and stakeholders in numerous ways; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves the new City of Elk Grove Improvement Standards, Construction Specifications, and Standard Drawings, with the new Improvement Standards to apply to all development applications not deemed complete as of this date, and the Construction Specifications to apply to all projects that have not received improvement plan review comments as of this date, and further authorizes the Public Works Director to amend the documents as (s)he deems necessary.




