

RESOLUTION NO. 2007-248

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION
CONTRACT IN THE AMOUNT OF \$32,220,080 WITH RGW CONSTRUCTION, INC.
FOR THE SHELDON ROAD/STATE ROUTE 99 INTERCHANGE RECONSTRUCTION
PROJECT AND AUTHORIZING THE CITY ENGINEER TO EXPEND
SUPPLEMENTAL AND CONTINGENCY FUNDS IN A NOT-TO-EXCEED AMOUNT
OF \$2,328,704 FOR ADDITIONAL PROJECT COSTS BEYOND THE
CONSTRUCTION CONTRACT**

WHEREAS, reconstructing the existing Sheldon Road/State Route 99 Interchange is a high priority for the City;

WHEREAS, on July 25, 2007 City Council authorized the City Engineer to call for bids on the Sheldon Road/State Route 99 Interchange Reconstruction Project (Project);

WHEREAS, on October 23, 2007, the City Clerk received six bids and RGW Construction, Inc. was the lowest responsive responsible bidder with a bid amount of \$32,330,080;

WHEREAS, reimbursement in the amount of \$1,719,757 for waterline improvements will be received from Sacramento County Water Agency; and

WHEREAS, additional supplemental and contingency funds, as necessary, in the amount of \$2,328,704 may be required to complete the construction of the Project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:


1. Authorizes the City Manager to execute a construction contract in the amount of \$32,220,080 with RGW Construction, Inc. for the Sheldon Road/State Route 99 Interchange Reconstruction Project; and
2. Authorizes the City Engineer to expend supplemental and contingency funds in a not-to-exceed amount of \$2,328,704 for additional project costs beyond the construction contract.


