**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE MAYOR TO EXECUTE A LETTER SEEKING A
REPRESENTATIVE FROM CALTRANS, GALT CITY COUNCIL AND LODI CITY
COUNCIL TO DISCUSS HIGHWAY 99 ISSUES IN A JOINT MEETING AND
AUTHORIZING THE MAYOR TO SERVE AS A REPRESENTATIVE FOR THE CITY
OF ELK GROVE IN THE DISCUSSION**

WHEREAS, the City of Elk Grove has identified State Route 99 as needing improvements through the Master Plan of Roadways in the Circulation Element of the General Plan and also in the adopted five-year Capital Improvement Program;

WHEREAS, the City of Elk Grove has completed a landscaping project at Bond Road/State Route 99 Interchange and serves as the lead agency currently constructing improvements at Grant Line Road/State Route 99 and Sheldon Road/State Route 99 Interchanges as well as preparing a Project Study Report for the Elk Grove Boulevard/State Route 99 Interchange;

WHEREAS, the City of Elk Grove recognizes that there continues to be various improvement and maintenance needs for the State Route 99 corridor through Elk Grove;

WHEREAS, the City of Elk Grove is interested in starting dialogue with Caltrans, Galt City Council and Lodi City Council to discuss State Route 99 issues in a meeting of representatives and determine if there is a consensus for continued examination as a group;

WHEREAS, a letter articulating the City's interest to convene a joint meeting has been prepared seeking a representative from Caltrans, Galt City Council and Lodi City Council; and

WHEREAS, the Mayor of the City of Elk Grove is available to serve as the City of Elk Grove's representative to discuss State Route 99 issues if there is a joint meeting with the parties above and available for any subsequent meetings.


