

RESOLUTION NO. 2008-156

RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS WITH AGATI INC. AND UNITED CORPORATE FURNISHINGS IN THE AMOUNT OF \$164,801.05 FOR THE PURCHASE OF TABLES, CARRELS, AND VARIOUS TYPES OF CHAIRS FOR THE ELK GROVE (OLD TOWN) LIBRARY PROJECT UTILIZING ESTABLISHED STATE OF CALIFORNIA AND NATIONAL JOINT POWERS ALLIANCE PROCUREMENT COOPERATIVE PURCHASING AGREEMENTS

WHEREAS, the furniture currently in use at the Elk Grove (Old Town) Library Project (Project) (Capital Improvement Project ID PF0011) has reached the end of its useful life; and

WHEREAS, the new "Old Town" Library interior spaces and furniture have been designed to take advantage of the two story building layout of various functional areas; and

WHEREAS, the furniture selected for the library has been reviewed and approved by the Library Design team to be comfortable, long lasting, and inviting; and

WHEREAS, section 3.42.220 of the Elk Grove Municipal Code allows for the voluntary participation by the City in cooperative purchasing agreement(s) or programs; and

WHEREAS, competitively bid contracts established by the State of California and the National Joint Powers Alliance are available to the City and, by utilizing these contracts, fixed quotes for the specified furniture have been provided by Agati Inc. in the amount of \$97,331.84 and by United Corporate Furnishings in the amount of \$67,469.21 for a combined total of \$164,801.05; and

WHEREAS, there is sufficient funding within the Project budget for these purchases.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute contracts with Agati Inc. and United Corporate Furnishings in the amount of \$164,801.05 for the purchase of tables, carrels, and various types of chairs for the Elk Grove (Old Town) Library Project utilizing established State of California and National Joint Powers Alliance procurement cooperative purchasing agreements.
